## SEASON TICKETS - TERMS AND CONDITIONS FOR VISITORS 2012

(Season Ticket applicants please read **before signing** and retain for reference)

### 1. Health and Safety

Children under 8 years of age must be closely supervised at all times by an adult aged 18 or above. It is recommended that under 5's are supervised on a one to one basis. Non swimmers and swimmers using buoyancy aids must stay within the designated area of the pool (as marked by the red line and signs). A non swimmer is someone who cannot swim 2 lengths of the pool unaided. The lifeguard's decision on this will be final.

Children aged 8 to 15 may use the Pool unaccompanied provided that they can swim 2 lengths non-stop competently. Anybody unable to swim 2 lengths non-stop must stay within the designated area and should be closely supervised at all times by an adult aged 18 or over.

Safety advice given by a lifeguard or the duty manager, and the pool rules and regulations, must be obeyed by all visitors.

For safety reasons it may be necessary to control admissions to the Pool during busy periods; this includes all types of season ticket holders.

### 2. Qualifying Dates and Proof of ID

*Season Tickets* – May 1<sup>st</sup> 2012 is the qualifying date for age-related concessions. *Season Tickets* will be issued individually, are not transferable and are available for use only by the named and photographed person. I.D is required for all those claiming *Concessions* and, unless the individual is obviously within the required age range, should be shown once, either at reception when applying in person or when collecting the ticket(s).

*Daily Tickets* and *Saver Tickets* (12 for 10) – The day of the visit is the qualifying date for age-related concessions. I.D is required for *Student* concessions but is not normally required for *Juniors* or *Seniors*; please do not be offended, however, if you look too old/young and are asked for I.D.

Portishead Open Air Pool tickets are not valid at any other pool.

### 3. Family Tickets

*Family Tickets* are for parents/partners and their children 15 and under (including foster children) or their student children living at the same address. Grandparents, cousins, foreign students, carers and child minders do not qualify. Children under 2 years are free.

### 4. Priority on Entry

If there is a queue at reception, *Season Ticket* holders may go to the front and alternate with those queuing to pay.

### 5. Summary of Categories

*Under 2 years* – no entry fee – must be closely supervised at all times by an adult 18 or over on a one-to-one basis.

*2-7 years* – *Junior* entry fee – must be closely supervised at all times by an adult aged 18 or over; a maximum of 2 children in this category can be supervised per adult.

*8-15 years* – *Junior* entry fee - must be closely supervised at all times by an adult 18 or over unless able to swim 2 lengths non-stop.

*Student in full time education* – *Student* entry fee.

*Adult aged 16-59 years* – *Adult* entry fee.

*Senior aged 60 or over* – *Senior* entry fee.

*Spectator* – *Spectator* entry fee – PPCT reserves the right to charge all *Spectators* (those who want to visit but not swim); however, those who visit purely to supervise a child aged under 16 may be allowed free entry on a discretionary basis if the Pool is not busy.
